**TRAFFIC & SAFETY** – 2024 Resident Survey indicated this was the #1 priority for residents.

# **Objectives**

 Work with residents and Town of Halton Hills staff to continue to address on-going traffic issues and their repercussions for residents from a holistic perspective, incorporating all areas of the Glen each with unique issues

### **2024 TRAFFIC & SAFETY INITIATIVES**

- ➤ Meet with Town of Halton Hills staff to review recommendations from GWCA shared evidence-based report of Glen residents traffic concerns, map to Town's approved 2024 Traffic Plan and identify gaps that require resolution
- Create plans with Town of Halton Hills staff to identify satisfactory resolutions to gaps between GWCA Traffic Report recommendations and Town's 2024 Traffic Plan
- Follow with the Town of Halton Hills staff, ensuring that all Glen designated projects in the Town's approved 2024 Traffic Plan are implemented as planned
- Continue to actively engage with Town of Halton Hill's on the following proposed projects in the Glen, advocating for local resident needs: Prince St. reconstruction, Main St. Bridge 1 and 2 reconstruction
- Continue to meet with Town of Halton Hills staff and other groups as appropriate, to advocate for ongoing traffic concerns

**PARKS & TRAILS -** 2024 Resident Survey indicated this was the #2 priority for residents, tied with Development.

### **Objectives**

- Work with Town of Halton Hills staff to ensure park areas and trails are maintained and are a recognized and important part of any developments in Glen Williams
- Partner with Town of Halton Hills Parks and Recreation Department to determine vision of parks and trails in Glen Williams to meet resident's current and future needs
- Consult with Credit Valley Conversation and other groups about trail initiatives and Credit River stewardship opportunities for the Glen
- Educate members about park, trail and river issues and promote activities through the newsletter and other formats

#### **2024 PARKS & TRAILS INITIATIVES**

- Adopt, Improve and Naturalize Shelagh Law Parkette
  - Apply for Town of Halton Hills Community Grant Program interpretive signage for back side of Kiosk – Jan
  - Replant for any winter loss May
  - · Continue to maintain gardens in Parkette ongoing
  - Coordinate with Town for spring installation of new park bench May
  - Apply for Town of Halton Hills Climate Sustainability Grant for native plants to naturalize along river's edge - May
  - Build/Install new Kiosk with Glen map and historical plaque May September
  - Host new Kiosk community celebration event September
- ➤ Partner with Birds for Halton to host World Migratory Bird Day event at Shelagh Law Parkette May 11
- ➤ Partner with Credit Valley Conservation for a large-scale planting of native shrubs and trees in the Glen Park, along river's edge May 25
- Continue to advocate for preservation of existing informal trails connecting Bishop Court and The Field to the core hamlet and development of more connected trail systems in the Glen, specifically the proposed Town of Halton Hills trail system behind 102 Confederation St. development, Bishop Court
- Continue to engage with Credit Valley Trails to ensure integration of the Glen in the Credit Valley Trails Walk project

**DEVELOPMENT -** 2024 Resident Survey indicated this was the #2 priority for residents, tied with Parks & Trails.

# **Objectives**

- Act as stewards of the Glen Williams Secondary Plan (GWSP)
- Help residents understand all components of GWSP
- Liaise with residents about proposed or on-going development projects and communicate potential impacts to residents and landscape and character of the Glen
- Engage with the Town of Halton Hills staff and Developers in all aspects of the planning and development process for designated developments, ensuring the GWSP is adhered to

#### **2024 DEVELOPMENT INITIATIVES**

- > 102 Confederation St. Development (Developer GWE)
  - Continue as a Participant, to actively work with Town and Developer following progress on conditions of approval and following on identified GWCA issues lists ensuring alignment with GWSP and continued well being and quality of life for current residents
- Megan/McMaster Development (Developer Eden Oak)
  - Continue as a Party, to actively participate in OLT settlement agreement process and oversee to ensure conditions of approval are followed through in alignment with the Glen Williams Secondary Plan and continued well being and quality of life for current residents
- > Glen Williams Secondary Plan OLT Appeal as filed by 3 developers in the Glen
  - Continue as a Party, to actively participate in ongoing OLT appeal hearing, advocating for alignment with Glen Williams Secondary plan and continued well being and quality of life for current residents
- Bishop Court Phase 2 planned development activities (Developer Charleston Homes)
  - Begin to review newest submission of materials from Charleston Homes and continue to actively monitor activity on this file. Engage with stakeholder(s) as required, advocating for alignment with Glen Williams Secondary Plan and continued well being and quality of life for current residents
- The Field Property 159 Confederation St.
  - Monitor any activity on the property. Review any documents made available. Engage with stakeholder(s) as required, advocating for alignment with Glen Williams Secondary Plan and continued well being and quality of life for current residents
- The Chase Development (Developer Eden Oak)
  - Monitor activities and respond to any issues arising from construction phase
- Committee of Adjustment:
  - Monitor monthly agendas and respond as required when variance requests filed by developers for Glen developments do not appear to be in alignment with approved plans or GWSP

**COMMUNITY ENGAGEMENT -** 2024 Resident Survey indicated this was the #4 priority for residents, however not far behind Parks & Trails & Development.
