We need to discuss this all further once we get going on our 'themes' and how to do the work.

Traffic

September 29th, 2021 the results from the 200 surveys received to date are being evaluated. The responses have been very diverse thus far. Kate will start analysis and send out results to all via email before the next meeting. Kate recommended that the GWCA have a meeting with the Town in January to discuss the results once the survey results are in.

Claudia stated that the Survey Monkey is a good tool. Kate said that, using a base of 1200 households, 200 responses was excellent, especially if the 'open' rate of the newsletter is 500, then this is amazing. But more can be done to make this top-notch.

Kate strongly advocated that the GWCA go door to door at some point in the future to 1) boost membership 2) discuss the GWCA and issues of concern and 3) continue to fill out traffic surveys

Kate suggested board members can start by canvassing their own areas and discuss areas of concern

<u>UPDATE ON DEVELOPMENT ETC PROJECTS – DEC 1, 2021 BOARD MTG</u>

DEVELOPMENTS

1. The Chase

- a. At the Oct 4/21 Council meeting, little detail was given of the actions planned to address the flooding. However within days (and with no alert to neighbors or GWCA), installation was started on a major drainage pipe (approx. 3' diameter) ending at entrance to stormwater sewer in front of Griffin property.
- b. DJR and Wayne Van Hinte have recently noted a "hands off" approach by Engineering.

2. McMaster-Megan

- a. DJR/B Cox met with Town reps on Nov 30 to discuss two outstanding issues re the plan.
 - i. GWCA provided details on prior construction issues when Wildwood was rebuilt.
 - ii. We pressured the Town to ensure a thorough plan for Wildwood construction. This is a major issue with impact for 1+ years on many residents.
 - iii. GWCA do not "like" proposed buffer size (5 possibly 6 metres)Case is weakened by editing of GWSP Update report to 5 10 meters.

Town (particularly Parks) don't agree with 5 meters but will be a difficult position to argue with updated GWSP. Suspect Town lawyer will recommend against opposing.

- b. OMB has called for a Case Management Conference meeting re M-M Jan 25/21
 - i. Has asked for a list of outstanding issues & proposed schedule. EO counsel to draft
 - ii. GWCA has Party status so have input to the discussions.Brian and Don feel we have gained all we are going to get re M-M.

DJR recommends we drop Party status and work with Town to create one shared list of issues. Must decided soon.

3. GWE

- a. Due to workload, GWCA team has yet to prepare rebuttals to developer's responses to GWCA's submitted list of issues.
- b. Plan to meet with Chris Sargent when have draft rebuttals prepared. Also to get material on their submittals and Town responses.

4. Bishop Court – Phase 2

- a. Nothing to report; GWCA yet to start formal review.
- b. People can present individual arguments/concerns; ignore the stated deadline.

Don Robinson
