Of note: Beginning 2025, there were three streams of income and expenditures: the GWCA, the Glen200 and the efforts of the GWCA re: 159 Confederation St. Field development.

### **Income**

Donations in 2025 came from community members, businesses via PayPal, e-transfer, Go-fund me and cash or cheque from various individuals and events held by the GWCA, the Glen200 Group and the Field Fundraising Group. This included items such as t-shirt sales, and silent auctions, sponsorships from the Federal government and the Town of Halton Hills and local businesses.

There were also various in-kind donations for printing, internet costs, refreshments, hall/meeting room rentals as well as landscaping, plants, etc. Fundraising was extensive for the Glen200 and the Field, through raffles, sales of items, a successful fall concert for the Field, etc.

Board members continued their work primarily in the areas of community engagement, parks & trails, communication, development, traffic and traffic safety in alignment with the 2025 Annual Plan. The following are key the accomplishments of 2025.

A primary focus was our continued stewardship of the Shelagh Law Parkette (Garden gang: Sandy Gillians Lead, Paul Griffin, Claudia Russell, Gary Russell, Stephen Groom, Mike & Dennie Brown, Lizanne Gray, Nathan Provost, Chelsea Griffin, Joan Griffin, Glenn Lowe, Lois Bastell). Focus also continued on the protection and enhancement of green spaces in the Glen, and educating residents about parks and trails issues.

➤ Continued as Stewards of the Shelagh Law Parkette & progressed Native Pollinator Habitat Transformation Project <ul style="list-style-type: none"><li>• Organized spring clean up of gardens event and replaced winter loss</li><li>• Organized tree planting event – 10 new native trees planted</li><li>• Continued to maintain gardens in Parkette – ongoing</li><li>• Installed two bird houses on kiosk</li><li>• Worked with Town to have new gravel put down on all paths in Parkette</li><li>• Worked with Town to complete wooden fencing along road side of Parkette</li></ul>
➤ Organized Town to pick up large pile of tree debris that was at base of staircase in Park to Meadows of Glen
➤ Continued to work with Councillors and Town staff to get frost free pipe in Glen Park to make it easier for volunteers to create the outdoor rink
➤ Glen200 – Purchased Christmas lights for the Parkette and put them up in partnership with Light Up The Hills team

## **BEAUTIFICATION**

Beautification efforts in 2025 were primarily focused on the Shelagh Law Parkette as covered under Parks & Trails and the annual Earth Day Event.

## **COMMUNICATION**

## **DEVELOPMENT**

The Development Committee (Stephen Groom, Mike Brown, Joan Griffin, Don Robinson, Doug McLachlin, and Andrew Shields) continued to focus on planning and development in the Glen, serving as stewards of the Glen Williams Secondary Plan (GWSP) in all proceedings with a focus on advocating that any proposed changes to the hamlet align with the requirements of the Plan. Our goal in reviews is to help protect and preserve the natural and cultural heritage features of the Hamlet; and, to guide change that maintains the unique character and natural environment of the Hamlet as well as the quality of life for residents.

Site work began April /24</li><li>➤ Communicated with Town and Councillors on numerous occasions advocating for Meagan/McMaster area residents facing challenges from site work in new development. Issues including trucks creating pedestrian safety risk, state of work site, dust, noise &amp; working hours on site</li><li>➤ Worked with Developer and Town to arrange open meeting for residents on Wildwood and select side streets interested in connecting to new sewer line</li></ul>
<p><b>Bishop Court Phase 2 planned development activities (Developer Charleston Homes)</b></p> <ul style="list-style-type: none"><li>➤ Site work started in 2025, with the cutting down of trees for entrance roadway. No additional site work was initiated in 2025 with exception of surveying for rejuvenation and extension of stormwater management ponds. GWCA Development Committee plans to meet Charleston Homes to affirm next steps, as part of oversight on the site works</li></ul>
<p><b>159 Confederation St., The Field Development – (Developer Eden Oak)</b></p> <ul style="list-style-type: none"><li>➤ Organized public zoom meeting to update community about application to build 81 townhomes &amp; 1 single detached home on Field property</li><li>➤ Sourced Legal Counsel and Snr. Planner given mandate from community in public meeting to register as Party with technical experts</li><li>➤ Organized public meeting for community to meet Lawyer and Snr. Planner and provide more updates on application</li><li>➤ Presented at Town Council the GWCA’s position and key concerns with this application</li></ul>

- Met regularly with Town staff and Councillors to reconfirm the community's position on this application
- Prepared for and began Mediation Assessment phase of Ontario Land Tribunal process
- Continued fundraising to cover legal and technical experts (Fundraising Committee – Claudia Russell Lead, Carolyn Maule, Sandy Gillians, Russell Gray, Michelle Jarvie)

**The Chase Development - (Developer Eden Oak)**

- Continued to follow up monthly with Town to better understand delay in opening of pedestrian path from Credit St. through new development to the rail trail. Path still not open

**Other**

- Requested meetings with Town staff to explore how individual monster homes being approved in hamlet
- Continued to support Stewarttown Community Association as they worked toward their first Ontario Land Tribunal proceedings
- Attended series of Town of Halton Hills Official Plan – Community Meetings

## **TRAFFIC & TRAFFIC SAFETY**

The Traffic & Traffic Safety Committee (Roger Stopford, Joan Griffin, Glenn Lowe, Kate Murray) continued to work with residents, Councillors and Town staff to address on-going traffic and traffic safety issues while protecting and preserving, maintaining and enhancing the nature of the hamlet.

### **2025 COMPLETED TRAFFIC & TRAFFIC SAFETY INITIATIVES**

- Initiated ongoing communication and meetings with Councillors and Town staff to address each of the priority issues currently impacting the Glen and Glen residents:
  - Initiated dialog towards establishing a plan to accommodate anticipated future visitor/tourist parking needs given increasing visitor/tourist traffic in hamlet core
  - Reviewed with Town staff the existing strategy to route truck traffic around the hamlet rather than transiting through the hamlet, given continued heavy truck traffic. Follow on discussion will focus on optimizing the implementation of this strategy
  - Discussed concrete next steps to address resident reports of traffic diverting onto side streets to avoid new speed bumps and driving at high speeds. Traffic measurement on affected side streets planned for 2026
  - Discussed impact of the planned 413 on traffic volumes transiting through the hamlet core, including continuing to measure traffic volumes in the hamlet
  - Collected hamlet signage data and discussed with Town staff given concerns about effectiveness of increasing signage pollution in hamlet
  - Initiated dialog to ensure the upcoming reconstruction of Main St. and Prince St. delivers roadways that are entirely consistent with the historic and heritage nature of the hamlet
  - Opened communication with Halton Police to get their attention on reported heavy traffic associated with the housing developments ignoring Stop signs

## **ENGAGEMENT WITH TOWN COUNCIL AND TOWN STAFF**

Continued our focus to create a greater awareness of the Glen and the GWCA and strengthen relationships with elected officials and Town Staff.

### **2025 COMPLETED ENGAGEMENT WITH TOWN COUNCIL & TOWN STAFF INITIATIVES**

#### **Elected Officials:**

- Continued ongoing communication with Mayor and Ward 2 Councillors. Providing information of GWCA initiatives, issues impacting the Glen/residents and requesting support at Council meetings where agendas specifically impacted the Glen/residents
- Invited all elected officials to attend all GWCA scheduled events
- Met with new MPP Joseph Racinsky to reconfirm priority issues of Glen residents, seeking his continued support in his new role
- Invited elected officials to contribute quarterly updates to the GWCA e-newsletter of information relevant to Glen residents

#### **Town of Halton Hills/Staff:**

- Continued ongoing communication and meetings with staff across key departments (Planning & Development, Traffic, Parks & Recreation, Culture & Equity, Diversity and Inclusion and Community Development) on a broad spectrum of issues impacting the Glen/residents and Glen200 Bicentennial celebrations
- Participated in the Town of Halton Hills Cultural Days Committee and Vision 2030 Advisory Group
- Provided feedback on the Town's proposed 2026 Budget Plan
- Presented at Council meeting encouraging Council to support increase in Community Grant Program
